Important event to be reported: Litigation before the Brasov Court

1. Through the action which is object of **File no. 1069/62/2016** registered with the Brasov Court, filed by SIF Transilvania against the defendants Constantin Frăţilă, Maria Alexandra Frăţilă, Gabriela Alexe, Ion Mărleneanu, Radu Toia, FDI CERTINVEST DINAMIC, FDI CERTINVEST XT INDEX, FDI CERTINVEST BET FI INDEX and FDI CERTINVEST PRUDENT (the last four funds being managed by SAI CERTINVEST S.A.), the company asked the Court to order the defendants to repair the damage caused to SIF Transilvania by committing illegal activities consisting in manipulation of capital market, dissemination of false and defamatory information, activities directed against the shares issued by SIF Transilvania.

2. Through the action which is object of **File no. 1070/62/2016** registered with the Brasov Court, filed by Mr. Mihai Fercală against the defendants Mr. Constantin Frăţilă and the Company Replica Expres S.R.L., Mr. Mihai Fercală asked the Court to find that the defendant Frăţilă Constantin has prejudiced the claimant's personal and non-material rights through a campaign of defamation in connection with the activity carried out as President of the Executive Board of SIF Transilvania, campaign illegally carried out by the defendant through the Company Replica Expres S.R.L. and order the defendants to pay damages.
