Important event to be reported: F.S.A. Decision regarding the presumption of an action in concert in relation to S.I.F. Transylvania S.A.

S.I.F. Transilvania informs the shareholders that the F.S.A., by Decision no. 1942 / 05.10.2016, found that the group of shareholders presumed to be acting in concert in relation to S.I.F. Transilvania, identified by F.S.A. Decision no. 983 / 25.04.2016, consisting of Constantin Frăţilă, Gabriela Alexe, Mărleneanu Ion, Alexa Business & Investments LLC Constanta, Saioc (Stancu) Mihaela, Pascu Narcisa, Amycris Trans LLC Constanta, Bobelea Ramona and Dragos Simion, has expanded to include two additional shareholders, respectively Frăţilă Maria Alexandra and Fratila Irina Elena. The group of shareholders presumed to be acting in concert in relation to S.I.F. Transilvania, identified by the F.S.A. Decision no. 1942/2016, holds collectively - as at 31.08.2016 - a stake of 7.4635% of the share capital.

As it follows from F.S.A. decisions no. 1935-1939 / 05.10.2016, not all individuals identified by Decision A.S.F. no. 983 / 25.04.2016 as part of the group presumed to be acting in concert in relation to S.I.F. Transilvania, abided by their obligation to comply with the provisions of Art. 286¹ par. (4) of Law no. 297/2004, as amended and supplemented.
