Decision no. 980/25.04.2016 through which he has been sanctioned on the grounds that S.I.F. Transilvania had not informed the public and the Authority with respect to the privileged information regarding the Files no. 5259/62/2015 and 5261/62/2015 registered with the Braşov Tribunal (see Current Report no. 3051 / 26.04.2016).

Mr. Mihai Fercaľă will appeal the decision within the legal deadline.
