Cookie Policy

According to [Regulation \(EU\) 2016/679](#) of the European Parliament and of the Council of 27 April 2016 *on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC* (General Data Protection Regulation), websites visitors are entitled to be informed of all data that is collected about them, the purpose of the collection, where and to whom such data is transmitted.

Transilvania Investments Alliance website (www.transilvaniainvestments.ro) uses cookies to provide visitors with an optimal browsing experience. Cookies serve to facilitate access and delivery of services used by Internet users, such as customizing certain settings (language, country, etc.).

Through this policy, we intend to inform you about the following aspects:

- What type of cookies exist on our website,
- For how long these cookies remain on the visitor's browsers,
- The purpose of these cookies.

The GDPR Regulation allows cookies to be stored on your equipment if they are strictly necessary for the proper functioning of the website.

What is a cookie?

A cookie is a small file that websites send to the browser and is stored on the user's device, such as personal computer, mobile phone, tablet, etc.

These files are used by the website to remember information about user visits, such as language preferences and other options.

How do we use cookies?

With the given consent, the user allows the installation of cookies on their device to tell us information, depending on the type of cookie used, such as :

- Statistical information regarding the use of the website
- Language preferences for the website etc.

What types of cookies we use:

Transilvania Investments Alliance website uses the following types of cookie:

1. *Strictly necessary cookies* without which we cannot ensure optimal functionality of the website. In relation to these cookies, you cannot express your choice, if you want to use this site.
2. *Functionality cookies* that collect information which is anonymized about how you use the website, for example, which pages you access most often, the language used. This data can be used to optimize the website and to facilitate your navigation within the web pages.
3. *Performance cookies* (statistical analysis) used to collect information about how users interact with our website, information that are to be analyzed to help us make improvements. They **are anonymized and cannot be used** to identify individual users.

The table below shows the cookies used by our website:

Certain sections of content on the website may be provided by third-parties, that is, not by Transilvania Investments Alliance S.A., in which case these cookies are called third-party cookies.

Google set a number of third-party cookies on any page that includes a Google map. Although we have no control over the cookies set by Google, they have the ability to collect data to measure the number and behavior of Google Maps users. Google has also set on any page that includes a form protected by reCAPTCHA v3 technology, the following cookies:
